

# On Edge Irregularity Strength of Mycielskian of Paths and Cycles

## Abstract

For a graph  $G$  having no loops and parallel edges, a labeling on the vertex set of  $G, \Psi: V(G) \rightarrow \{1, 2, \dots, \alpha\}$  is referred to  $\alpha$ -labeling. Let  $ab \in E$  be an edge. Then the weight the edge  $ab$  is  $z_\Psi(ab) = \Psi(a) + \Psi(b)$ . An  $\alpha$ -labeling on the vertex set of  $G$  is referred to be an edge irregular  $\alpha$ -labeling of  $G$  if  $z_\Psi(a) \neq z_\Psi(b)$ , where  $a \neq b$  in  $G$ . The least number  $\alpha$  for which the graph  $G$  has an edge irregular  $\alpha$ -labeling is referred to the edge irregularity strength of  $G$ , written  $es(G)$ . The edge irregularity strength of Mycielskian of paths and cycles is computed.

**Keywords:** Edge Irregularity Strength, Mycielskian of Paths and Cycles

## 1.0 Introduction

In a simple connected graph  $G$ , where  $V(G)$  and  $E(G)$  represent the vertex set and edge set, allocating positive integers to a set of vertices (points), edges (lines), or both, while meeting specific constraints, is referred to as *graph labeling*. Graph labeling has various applications in mines and mining operations to model and solve different problems in the mining industry, such as resource allocation and scheduling, safety and risk management, supply chain management, geological mapping, and exploration, etc.

For a given graph  $G$ , the edges are assigned the natural numbers so that the addition of the assignment of labels to the edges of every vertex is different. Such labeling is termed the irregular labeling of the graph  $G$ <sup>1</sup>. The least value among the maximum label which is assigned to an edge of a graph  $G$  is termed as the *irregularity strength*

of  $G$ , written  $s(G)$ . Calculating  $s(G)$  seems to pose challenges, even when dealing with a graph  $G$  of a basic structure<sup>1</sup>. In their work, Ahmad *et al.*<sup>2</sup> proposed the concept of edge irregular  $\alpha$ -labelings for graphs, drawing inspiration from Chartrand *et al.*<sup>1</sup>. A labeling  $\Psi$  on the vertices  $V(G)$  with values from the set  $\{1, 2, \dots, \alpha\}$  is referred to an  $\alpha$ -labeling.

If, for any pair of distinct edges labeled as  $a$  and  $b$ ,  $z_\Psi(a) \neq z_\Psi(b)$ , then an  $\alpha$ -labeling on  $V(G)$  is referred to an edge irregular  $\alpha$ -labeling of  $G$ . The minimum value of  $\alpha$  for which the graph  $G$  possesses an edge irregular  $\alpha$ -labeling defines the edge irregularity strength, denoted as  $es(G)$ .

The construction of the Mycielskian graph for a given graph  $G$  is outlined in <sup>3</sup> as follows.

The *Mycielskian* of a graph  $G$ , represented by  $\mu(G)$ , where  $G$  has a vertex set  $V(G) = \{a_1, a_2, \dots, a_n\}$ , is the graph

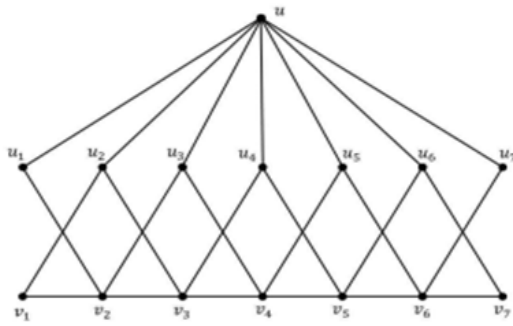


Figure 1. The Mycielskian of a path  $P_7$ .

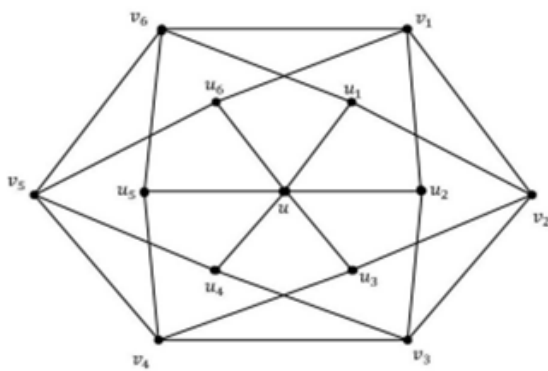


Figure 2. The Mycielskian of a cycle  $C_6$ .

with  $V(\mu(G)) = \{a_1, a_2, \dots, a_n, b_1, b_2, \dots, b_n, c\}$  such that  $a_i, a_j \in (\mu(G)) \iff a_i, a_j \in E(G); a_i, b_j \in E(\mu(G)) \iff a_i, a_j \in E(G);$  and  $b_i, c \in E(\mu(G)), \forall i=1,2,\dots,n.$

The Mycielskian of a path  $P_7$  and a cycle  $C_6$  is shown in Figures 1 and 2, respectively.

## 2.0 Initial Findings

Chartrand *et al.*<sup>1</sup> established both the upper and lower bounds for  $es(G)$  in a given graph  $G$ . They also determined the precise values of  $es(G)$  for paths  $P_n$  with order at least two, cycles  $C_n$  with order at least 3, star graph  $K_{1,n}$  with order  $n+1$  where  $n \geq 1$ , and double star  $S_{m,n}$  with  $3 \leq m \leq n$ . Additionally, the authors<sup>4,5</sup> determined the edge irregularity strength for Toeplitz graphs and the corona product of graphs with paths, respectively. The exact value of  $es(\mu(G))$ , where  $G$  is disjoint union of graphs is determined<sup>6</sup>. The  $es(\mu(G))$ , where  $G$  is the sunlet graph is computed<sup>7</sup>;  $es(\mu(L(G)))$  and  $es(\mu(L_c(G)))$ , where  $L(G)$  is the line graph and  $L_c(G)$  is the line cut-vertex graph

of  $G$ , respectively<sup>8</sup>. For more information on finding the irregularity strength of graphs, see<sup>9-20</sup>.

Inspired by the aforementioned research, we calculate  $es(\mu(G))$ , with  $G$  representing both a path and a cycle.

The following theorem presented in<sup>2</sup> facilitates the exploration of either the precise value or the limits of  $es(G)$ , as it gives the minimum value of  $es(G)$  for a given graph  $G$ .

**Theorem 2.1** Consider  $\Delta(G)$  to be the maximum degree within a simple graph  $G$ . Then

$$es(G) \geq \max \left\{ \left\lceil \frac{|E(G)| + 1}{2} \right\rceil, \Delta(G) \right\}$$

## 3.0 Edge Irregularity Strength in the Mycielski Transformation of Paths

This section focuses on identifying the edge irregularity strength of Mycielski transformation of paths. The following result in<sup>2</sup> is well known.

**Theorem 3.1** Consider  $C_n$  as a cycle of order on  $n \geq 3$ . Then

$$es(C_n) = \begin{cases} \left\lceil \frac{n}{2} \right\rceil & \text{for } n \equiv 1 \pmod{4} \\ \left\lceil \frac{n}{2} \right\rceil + 1 & \text{otherwise} \end{cases}$$

With the aid of Theorem 3.1, we establish  $es(\mu(P_n))$ ,  $n \geq 2$  in the subsequent theorem.

Using Theorem 3.1, we find  $es(\mu(P_n))$ ,  $n \geq 2$ , in the next theorem.

**Theorem 3.2** Let  $G = P_n$  be a path of order  $n \geq 2$ . Then  $es(\mu(G)) = [2n-1]$  for  $n=2,3$ .

Furthermore,

$$[2n - 1] \leq es(\mu(G)) \leq \left\lceil \frac{5n-4}{2} \right\rceil \text{ for } n \equiv 2 \pmod{2};$$

$$[2n - 1] \leq es(\mu(G)) \leq \left\lceil \frac{5n-3}{2} \right\rceil \text{ for } n \equiv 1 \pmod{2}, n \neq 3.$$

**Proof.** Consider  $G$  to be a path  $P_n$  be a path of order  $n \geq 2$ . We have the cases as mentioned below.

**Case 1:** For  $G = P_2$ ,  $G \cong C_3$ . By Theorem 3.1,  $es(\mu(G)) = 3 = [2n-1]$ .

**Case 2:** For  $G = P_3$ , let  $V(\mu(G))$  and  $E(\mu(G))$  of  $\mu(G)$  be as follows:

$$V(\mu(G)) = \{x, x_i: 1 \leq i \leq 3\} \cup \{y_j: 1 \leq j \leq 3\};$$

$$E(\mu(G)) = \{xx_i: 1 \leq i \leq 3\} \cup \{y_j y_{j+1}: 1 \leq j \leq 2\} \\ \cup \{x_1 y_2, x_3 y_2, x_2 y_1, x_2 y_3\} \\ \cup \{x_1 y_2, x_3 y_2, x_2 y_1, x_2 y_3\}$$

Hence,  $|V(\mu(G))|=7$ ,  $|E(\mu(G))|=9$ , and  $\Delta(\mu(G))=4$ .

According to Theorem 2.1,  $es(\mu(G))$  is guaranteed to be at least  $\max\{5, 4\}$ . Thus  $es(\mu(G))=5=\lceil 2n-1 \rceil$ .

Finally, it is enough to show the presence of an edge irregular  $\lceil 2n-1 \rceil=5$ -labeling to prove the equality.

Let  $\Psi: V(\mu(G)) \rightarrow \{1, 2, \dots, 5\}$  be a labeling on  $V(\mu(G))$  such that  $\Psi(x)=5$ ;  $\Psi(x_i)=i+2$  for

$$1 \leq i \leq 3; \Psi(y_j)=1 \text{ for } 1 \leq j \leq 2; \Psi(y_3)=2.$$

**The edges carry the following weights:**

$$z_\Psi(xx_i) = i + 7 \text{ for } 1 \leq i \leq 3;$$

$$z_\Psi(x_i y_{i+1}) = 2(i + 1) \text{ for } 1 \leq i \leq 2;$$

$$z_\Psi(x_3 y_1) = 6; w_\phi(x_3 y_3) = 7;$$

$$z_\Psi(y_j y_{j+1}) = j + 1 \text{ for } 1 \leq j \leq 2.$$

Clearly, every pair of distinct edges has a different edge weight. Therefore,  $es(\mu(G))=\lceil 2n-1 \rceil=5$ .

Figure 3 shows the edge irregularity strength of  $es(\mu(P_3))$ , where the maximum degree  $\Delta=4$  and  $|E(\mu(G))|=9$ .

**Case 3:** Let  $G=P_n$  be a path, where  $n \equiv 1, 2 \pmod{2}, n \neq 3$ .

Let  $V(\mu(G))$  and  $E(\mu(G))$  of  $\mu(G)$  be as follows:

$$V(\mu(G)) = \{x, x_i: 1 \leq i \leq n\} \cup \{y_j: 1 \leq j \leq n\};$$

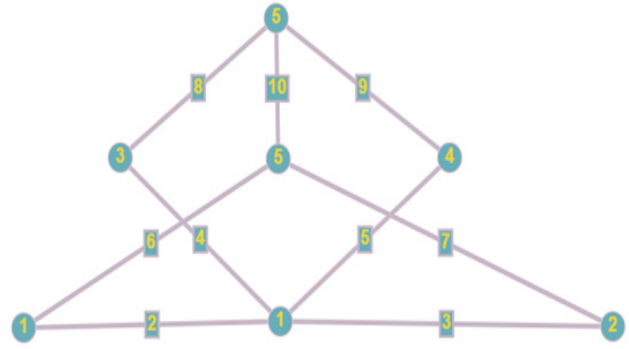
$$E(\mu(G)) = \{xx_i: 1 \leq i \leq n\} \cup \{y_j y_{j+1}: 1 \leq j \leq n-1\} \\ \cup \{x_i y_{i+1}: 1 \leq i \leq n-1\} \\ \cup \{x_i y_{i-1}: 2 \leq i \leq n\}.$$

Clearly,  $|V(\mu(G))|=2n+1$ ,  $|E(\mu(G))|=4n-3$ , and  $\Delta(\mu(G))=n$ .

By Theorem 2.1,  $es(\mu(G)) \geq \max\{\lceil 2n-1 \rceil, n\}$ . As  $\lceil 2n-1 \rceil$  is greater than  $n$  for  $n \geq 4$ , it can be concluded that  $es(\mu(G)) > \lceil 2n-1 \rceil$ .

Let  $\Psi$  be a vertex labeling on  $V(\mu(G))$  in order to get the upper bound.

$$\text{Let } \Psi: V(\mu(G)) \rightarrow \left\{1, 2, \dots, \left\lceil \frac{5n-4}{2} \right\rceil\right\} \text{ such that}$$

$$\Psi(x_{2i-1}) = n - 3(1 - i) \text{ for } 1 \leq i \leq \frac{n}{2};$$

$$\Psi(x_{2i}) = n - 2 + 3i \text{ for } 1 \leq i \leq \frac{n}{2};$$

$$\Psi(y_{2j-1}) = j \text{ for } 1 \leq j \leq \frac{n}{2};$$

$$\Psi(y_{2j}) = j \text{ for } 1 \leq j \leq \frac{n}{2}$$

**The edges carry the following weights:**

$$z_\Psi(xx_{2i-1}) = 3(n + i) - 4 \text{ for } 1 \leq i \leq \frac{n}{2};$$

$$z_\Psi(xx_{2i}) = 3(n - 1 + i) \text{ for } 1 \leq i \leq \frac{n}{2};$$

$$z_\Psi(y_j y_{j+1}) = j + 1 \text{ for } 1 \leq j \leq n - 1;$$

$$z_\Psi(x_i y_{i+1}) = 2i - 1 + n \text{ for } 1 \leq i \leq n - 1;$$

$$z_\Psi(y_j y_{j+1}) = 2j + n \text{ for } 1 \leq j \leq n - 1.$$

Clearly, every pair of distinct edges has a different edge weight. Hence  $\Psi$  is an edge irregular labeling with  $\lceil (5n-4)/2 \rceil$  labels, that is,  $es(G) \leq \lceil (5n-4)/2 \rceil$  for  $n \equiv 2 \pmod{2}$ .

**Case 4:** For  $n \equiv 1 \pmod{2}, n \neq 3$ , in accordance with Theorem 2.1,  $es(\mu(G)) > \lceil 2n-1 \rceil$ .

For the upper bound, let

$$\Psi: V(\mu(G)) \rightarrow \left\{1, 2, \dots, \left\lceil \frac{5n-3}{2} \right\rceil\right\} \text{ be the vertex}$$

labeling on  $V(\mu(G))$  such that

$$\Psi(x) = 2n - 1; \Psi(x_{2i-1}) = n - 3(1 - i) \text{ for } 1 \leq i \leq \lfloor \frac{n}{2} \rfloor;$$

$$\Psi(x_{2i}) = n - 2 + 3i \text{ for } 1 \leq i \leq \lfloor \frac{n}{2} \rfloor;$$

$$\Psi(y_{2j-1}) = j \text{ for } 1 \leq j \leq \lfloor \frac{n}{2} \rfloor;$$

$$\Psi(y_{2j}) = j \text{ for } 1 \leq j \leq \lfloor \frac{n}{2} \rfloor.$$

The edges carry the following weights:

$$z_{\Psi}(xx_{2i-1}) = 3(n + i) - 4 \text{ for } 1 \leq i \leq \lfloor \frac{n}{2} \rfloor;$$

$$z_{\Psi}(xx_{2i}) = 3(n - 1 + i) \text{ for } 1 \leq i \leq \lfloor \frac{n}{2} \rfloor;$$

$$z_{\Psi}(y_j y_{j+1}) = j + 1 \text{ for } 1 \leq j \leq n - 1;$$

$$z_{\Psi}(x_i y_{i+1}) = 2i - 1 + n \text{ for } 1 \leq i \leq n - 1;$$

$$z_{\Psi}(y_j y_{j+1}) = 2j + n \text{ for } 1 \leq j \leq n - 1.$$

Clearly, every pair of distinct edges has a different edge weight. Hence  $\Psi$  is an edge irregular labeling with  $\lfloor (5n-3)/2 \rfloor$  labels, that is,  $es(G) \leq \lfloor (5n-3)/2 \rfloor$  for  $n \equiv 1 \pmod{2}, n \neq 3$ . Hence, the proof.

### 4.0 Edge Irregularity Strength of Mycielskian of Cycles

This section focuses on identifying the edge irregularity strength of Mycielski transformation of cycles.

In the next theorem, we find  $es(\mu(C_n)), n \geq 3$ .

**Theorem 4.1** Consider  $G$  to be a cycle  $C_n, n \geq 3$ . Then,

$$\lfloor \frac{4n+1}{2} \rfloor \leq es(\mu(G)) \leq 12i \text{ for } n = 2(1 + i), i \geq 1.$$

$$\lfloor \frac{4n+1}{2} \rfloor \leq es(\mu(G)) \leq 12i - 3 \text{ for } n = 2i + 1, i \geq 1.$$

**Proof.** Consider  $G$  to be a cycle  $C_n, n \geq 3$ . Initially, we establish the result for  $n=4$ .

For  $G=C_4$ , let  $V(\mu(G))$  and  $E(\mu(G))$  of  $\mu(G)$  be as follows:

$$V(\mu(G)) = \{x, x_i: 1 \leq i \leq 8\};$$

$$E(\mu(G)) = \{x_1x_4, x_ix_{i+1}: 1 \leq i \leq 3\}$$

$$\cup \{xx_i: 5 \leq i \leq 8\}$$

$$\cup \{x_1x_6, x_1x_8, x_2x_5, x_2x_7, x_3x_6, x_3x_8, x_4x_5, x_4x_7\}$$

Hence  $|V(\mu(G))|=9, |E(\mu(G))|=16$ , and  $\Delta(\mu(G))=4$ .

According to Theorem 2.1,  $es(\mu(G))$  is guaranteed to be at least  $\max\{9,4\}$ .

Hence  $es(\mu(G)) \geq 9 = \lfloor (4n+1)/2 \rfloor$ .

In conclusion, demonstrating the existence of an edge irregular 12- labeling is sufficient to establish equality.

Let  $\phi: V(\mu(G)) \rightarrow \{1,2,\dots,5\}$  be labeling on  $V(\mu(G))$  such that

$$\Psi(x) = 12; \Psi(x_i) = i \text{ for } 1 \leq i \leq 2;$$

$$\Psi(x_i) = (2 + i) - 2j \text{ for } 3 \leq i \leq 4, 0 \leq j \leq 1;$$

$$\Psi(x_5) = 2, \Psi(x_6) = 11, \Psi(x_7) = 2, \Psi(x_8) = 10.$$

The edges carry the following weights:

$$z_{\Psi}(xx_5) = 14, z_{\Psi}(xx_6) = 23,$$

$$z_{\Psi}(xx_7) = 18, z_{\Psi}(xx_{10}) = 22;$$

$$z_{\Psi}(x_1x_2) = 3, z_{\Psi}(x_2x_3) = 7,$$

$$z_{\Psi}(x_3x_4) = 9, z_{\Psi}(x_1x_4) = 5;$$

$$z_{\Psi}(x_1x_6) = 11, z_{\Psi}(x_2x_5) = 4,$$

$$z_{\Psi}(x_3x_6) = 16, z_{\Psi}(x_4x_5) = 6;$$

$$z_{\Psi}(x_1x_8) = 11, z_{\Psi}(x_2x_7) = 8,$$

$$z_{\Psi}(x_3x_8) = 15, z_{\Psi}(x_4x_7) = 10.$$

Clearly, every pair of distinct edges has a different edge weight. Therefore,  $es(\mu(G))=12$ .

Let  $G=C_n$  be a cycle of order  $n \geq 5$ .

$$V(\mu(G)) = \{x, x_i: 1 \leq i \leq 2n\};$$

$$E(\mu(G)) = \{x_1x_n, x_ix_{i+1}: 1 \leq i \leq n - 1\}$$

$$\cup \{xx_i: n + 1 \leq i \leq 2n\}$$

$$\cup \left\{ \begin{matrix} x_1x_{n+2}, x_2x_{n+1}, x_ix_{2(n-1)-j}: \\ 3 \leq i \leq n, 0 \leq j \leq n - 3 \end{matrix} \right\}$$

$$\cup \left\{ \begin{matrix} x_1x_{2n}, x_2x_{2n-1}, x_ix_{2n-j}: \\ 3 \leq i \leq n, 0 \leq j \leq n - 3 \end{matrix} \right\}$$

**Case 1:** For  $n=2(i+1), i \geq 2$ ,  
 $|V(\mu(G))|=2n+1$ ,  $|E(\mu(G))|=4n$ , and  $\Delta(\mu(G))=n$ .

By Theorem 2.1,  $es(\mu(G)) \geq \max\{[(4n+1)/2], n\}$ . Since  $[(4n+1)/2] > n$  for any  $n=2(i+1), i \geq 2$ ,

$$es(\mu(G)) \geq [(4n+1)/2].$$

Let  $\Psi: V(\mu(G)) \rightarrow \{1, 2, \dots, 12i\}, i \geq 2$ , such that

$$\Psi(x) = n; \Psi(x_n) = -1 + n;$$

$$\Psi(x_i) = i \text{ for } 1 \leq i \leq n - 1;$$

$$\Psi(x_{n+1}) = n;$$

$$\Psi(x_{n+2}) = 2n - 1;$$

$$\Psi(x_{n+3}) = 2n + 1;$$

$$\Psi(x_{n+4}) = 2(n + 2);$$

$$\Psi(x_{n+i+4}) = 2n + 4(1 + i) \text{ for } 1 \leq i \leq n - 4.$$

**The edges carry the following weights:**

$$z_\Psi(x_1x_n) = n;$$

$$w_\phi(x_i x_{i+1}) = 2i + 1 \text{ for } 1 \leq i \leq n - 2;$$

$$z_\Psi(x_i x_{i+1}) = 2i \text{ for } i = n - 1;$$

$$z_\Psi(xx_{n+3}) = 7(n - 1);$$

$$z_\Psi(xx_{n+i+1}) = 7n + 2i - 11 \text{ for } 1 \leq i \leq 2;$$

$$z_\Psi(xx_{n+i+3}) = 7n + 4i - 8 \text{ for } 1 \leq i \leq n - 3;$$

$$z_\Psi(x_1x_{n+2}) = 2n; w_\phi(x_2x_{n+1}) = n + 2;$$

$$z_\Psi(x_i x_{(2n-2)-j}) = 6n - 3j - 17 \text{ for } 3 \leq i \leq n - 3, 0 \leq j \leq n - 6;$$

$$z_\Psi(x_i x_{n-j+3}) = i + 1 - 2(j - n) \text{ for } -2 \leq i \leq n - 1; 0 \leq j \leq 1;$$

$$z_\Psi(x_n x_{n+1}) = 2n - 1;$$

$$z_\Psi(x_1 x_{2n}) = 6n - 11;$$

$$z_\Psi(x_2 x_{2n-1}) = 2(3n - 7);$$

$$z_\Psi(x_i x_{2n-j}) = 6(n - 1) - i - 2j \text{ for } 3 \leq i \leq n; 0 \leq j \leq n - 3.$$

Clearly, every pair of distinct edges has a different edge weight. Therefore,  $es(\mu(G))=12i, i \geq 2$ .

**Case 2:** For  $n=2i+1, i \geq 1$ , by Theorem 2.1,  $es(\mu(G)) \geq [(4n+1)/2]$ .

Let  $\Psi: V(\mu(G)) \rightarrow \{1, 2, \dots, 12i-3\}, i \geq 1$ , such that

$$\Psi(x) = 5n - 6; \Psi(x_i) = i \text{ for } 1 \leq i \leq n;$$

$$\Psi(x_{n+1}) = n + 1; \Psi(x_{n+2}) = 2n + 1;$$

$$\Psi(x_{n+2+i}) = 2n + i + 3j + 2$$

$$\text{for } 1 \leq i \leq n - 2; 0 \leq j \leq n - 3.$$

**The edges carry the following weights:**

$$z_\Psi(x_1x_n) = n + 1; w_\phi(x_i x_{i+1}) = 2i + 1 \text{ for } 1 \leq i \leq n - 1;$$

$$z_\Psi(xx_{n+1}) = 6n - 5; w_\phi(xx_{n+2}) = 7n - 5;$$

$$z_\Psi(xx_i) = (7n - 3) + 4j \text{ for } n + 3 \leq i \leq 2n, 0 \leq j \leq n - 3;$$

$$z_\Psi(x_1x_{n+2}) = 2(n + 1);$$

$$z_\Psi(x_2x_{n+1}) = n + 3.$$

$$\text{For } n = 3, w_\phi(x_n x_{n+1}) = 2n + 1.$$

$$\text{For } n = 2i + 1, i \geq 2,$$

$$z_\Psi(x_i x_{2(n-1)-j}) = 6n - 4 - 3j \text{ for } 3 \leq i \leq n - 2, 0 \leq j \leq n - 5;$$

$$z_\Psi(x_{n-1}x_{n+3}) = 3n, z_\Psi(x_n x_{n+1}) = 2n + 1;$$

$$z_\Psi(x_1x_{2n}) = 6n - 8; z_\Psi(x_2x_{2n-1}) = 6n - 11;$$

$$z_\Psi(x_i x_{2n-j}) = 6(n - 1) - 3j \text{ for } 3 \leq i \leq n; 0 \leq j \leq n - 3.$$

Clearly, every pair of distinct edges has a different edge weight. Therefore,  $es(\mu(G))=12i+3, i \geq 1$ .

## 5.0 Conclusions

This paper presents findings on the limits of edge irregularity strength for Mycielskian transformations

applied to paths and cycles. Nevertheless, discovering the precise value or limits for the edge irregularity strength of many other important classes of graphs, such as the line graph, total graph, middle graph, etc., of Mycielskian paths and cycles remain open. Graph labeling can be applied to represent the mining operations as a graph, where vertices represent tasks or activities, and edges represent dependencies or constraints. Labels can then be assigned to vertices or edges to indicate resource requirements, processing times, or other relevant parameters. This facilitates the optimization of resource allocation and scheduling for efficient mine operations.
